- The last date of submission of offline applications is 16th June 2025 by 05:00 PM IST. The last date is the cut-off date for all purposes, including Age/Qualification/experience, etc.
- The Walk-In-Interview will be on 20th June 2025, 11:00 hrs onwards at the conference hall of Centre for Earth Sciences and Himalayan Studies, An autonomous organization under Department of Science & Technology, Government of Arunachal Pradesh 1st Floor Alexander House, Mowb-I, Opposite to Indira Gandhi Park, VIP Road, Itanagar Arunachal Pradesh 791111.
- 3. The prescribed essential qualifications are minimum, and the mere possession of the same does not entitle candidates to be called for interview. If the number of applications received in response to an advertisement is large, it will not be convenient or possible for the Selection Board to interview all those candidates. The Centre may restrict the number of candidates to be called for interview to a reasonable limit of desirable qualification and/or on the record of academic performance and/or relevant experience for the post prescribed in the advertisement as per the specific requirement of the Centre and/or any other benchmark decided by a committee constituted to screen the applications. No correspondence will be entertained with candidates who are not called for an Interview.
- Canvassing in any form and/or bringing any influence, political or otherwise, will be treated as a disqualification of candidature. No interim correspondence/inquiry will be entertained.
- 5. Candidates working in Government/Public Sector Undertakings/Autonomous bodies must produce the requisite 'No Objection Certificate' from their employer at the time of interview.
- Experience will be counted after completion of essential academic qualifications, while a completed doctorate degree will be counted as three years' experience in case the doctorate is not mentioned in the essential qualification.
- 7. In case a candidate has obtained the above degree while in service, only his /her service period will be counted towards experience, and he/she will not get any additional weightage in experience for acquiring
- 8. The selection for the posts shall be on the basis of the performance of the screened-in candidates in the interview. Director CESHS reserves the right to decide on the mode of interview, either online/offline, and in case of online mode, through any available online video conferencing mode.
- Offline applications submitted without the photo, signature, and scanned copies of the Certificates will be rejected.
- 10. The selected candidates are liable to serve in Arunachal Pradesh.
- 11. No traveling advance will be paid for attending the interview.
- The candidates need to make their own stay arrangements. CESHS will not be responsible for any accommodation arrangements.
- Director, CESHS has the right to cancel the recruitment process at any stage, without assigning any reason thereof, or vary the number of posts to be filled under each category.
- 14. Discrepancies found in the certificate or concealing of facts will attract the disqualification of the application/termination/disqualification from future recruitments (as applicable). Nonproduction of the original certificates at the time of the interview will also make the candidate disqualified.

- 15. Production of the original certificate at the time of interview is must. Candidates currently working in any other organization need to provide proof of their current employment with a service/experience certificate from the employer. An appointment order will not be considered as proof of current employment.
- 16. All project positions are purely temporary and on project mode and do not entitle the candidate to any claim for a regular/permanent position at any time. The contract may be extended periodically, subject to satisfactory performance.
- 17. All future updates/amendments, etc., on the instant recruitment shall be uploaded on the CESHS website only. Accordingly, all candidates are advised to visit the official CESHS website regularly.
- 18. **Application procedure:** The entire application procedure is offline. Candidates must produce the original certificates while appearing for an interview or as and when required. If the certificates are in a language other than English or Hindi, attested translation should be provided.
